

About National Council Against Drug Abuse

NCADA is a Citizen's Advisory Council to MHA on policies and upstream measures for the prevention of drug abuse in Singapore.

The Council aims to mobilise the public for the anti-drug mission, in support of the drug-free vision for Singapore.



Administered by NCADA on behalf of the Ministry of Home Affairs, grant application is open throughout the year.

Please allow appropriate lead-time for discussion and processing of application. On-going projects will not be considered.

Eligibility

Grantees should be Singaporeans, PRs or communities/groups based in Singapore.

The project, or the anti-drug component of the project, should be not-for-profit.

Support Level

Up to 100% reimbursement with full attainment of mutually-agreed Performance Targets (KPIs).



Qualifying costs include:

- Expenses for third party services e.g. logistics, event management etc.
- Marketing & PR
- Welfare expenses for Target Audience e.g. F&B costs
- In-house manpower for development of content requiring subject matter experts

This is a grant supporting ground-up initiatives that contribute to the vision of a drug-free Singapore, such as:

- Awareness-building for Preventive Drug Education
- Projects to ignite conversations on the harms of drugs
- Capability development for anti-drug advocacy
- Projects targeting Youths or Parents preferred

*Note: The maximum sum NCADA will disburse is capped at the support level of the **actual cost** incurred by the Grantee for the Qualifying Costs.*

- Upfront disbursements are granted on a case-by-case basis, up to \$3,000.
- Projected milestones should be listed if milestone grant disbursement is requested for long project durations (subject to approval)
- No double-funding of line items if funding is sought from more than one source.

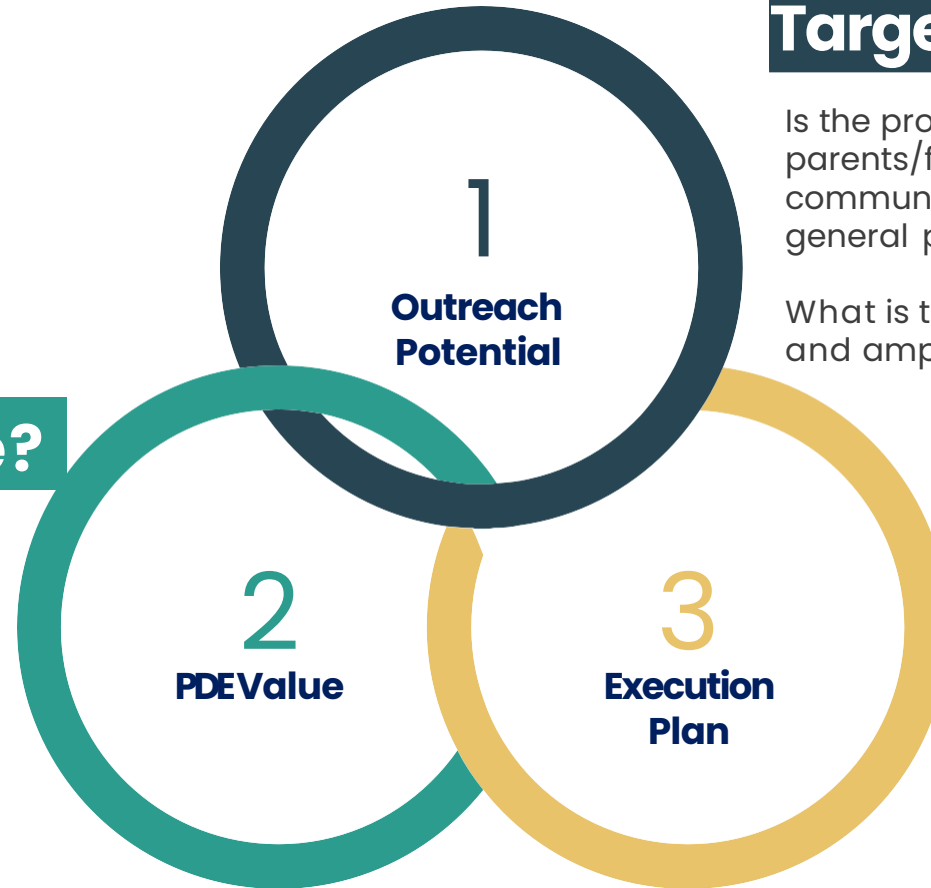
How are projects evaluated?

To note:

- A **post-event report** must be submitted alongside other supporting documents (e.g. receipts, invoices, event photos, media performance statistics) for performance assessment.
- Grantees will need to provide alternative targets and/or **justifications** for any unavailable documentation.
- Failure to meet performance targets or lower actual expenditure would result in a **prorated disbursement**.
