

TELEGRAM: ANONYMOUS PLATFORM TO MAKE DRUG DEALS?

CNB has been monitoring suspected drug activities on Telegram since 2019, with more than 460 suspects arrested in the last four years. ASP Leslie Lee, OC Intelligence Collection, said in an email interview with LHZB that drug offenders are constantly changing their crime patterns, including conducting illicit drug transactions on online platforms such as Telegram. These drug offenders may think that such applications, which promotes privacy features such as message encryption, secret channels, self-destructing media, etc. can offer them a certain level of anonymity to carry out their illegal activities and evade CNB's surveillance. This, however, is untrue, and there is no haven for drug offenders in Singapore regardless of the platform or tactics used.

WHAT THIS MEANS FOR ANTI-DRUG ADVOCACY

On 10 Jan 2023 two Singaporean brothers (17 and 25) were arrested for suspected drug activities related to transactions conducted over Telegram. This case is certainly not the first of its kind, and it points to two issues – firstly, the use of instant message for illicit activities such as drug sales and trafficking; and secondly, that youths and young people are amongst those looking to exploit such apps for illicit purposes. With platforms like Telegram being easily accessible by anyone with a smartphone, the potential of wrongful usage remains ever–present.

WHAT CAN YOU DO?

It is helpful to share reminders with family and friends to be mindful about the kind of group chats, channels, or conversations they may join on platforms like Telegram, WhatsApp, LINE, Signal, etc. in case they may inadvertently stumble upon sites which promote illicit or unsavory content. In the event that they accidentally come across such channels, they may wish to use the in-app 'report' function or alert the relevant authorities (e.g., CNB for drug-related matters, HSA for vape-related matters, SPF for general suspicious activities, etc.) at their respective communication channels. If, however, they may be tempted to partake in such exchanges despite knowing that it is illegal, advocates may like to highlight that such "anonymous" features are not very anonymous at all and that they may run into trouble with the law should they give in to curiosity.
